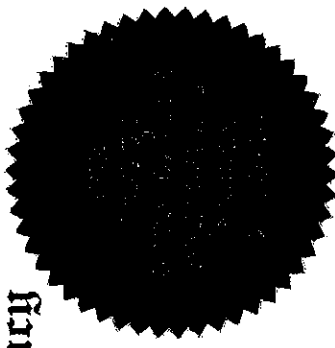
WHEREAS, during his tenure, Director McIntyre has served with distinction and contributed significantly to the successful operation of the Fox Canyon Groundwater Management Agency.
